7.1. Precautions for safe handling

Safe use of the product	 Avoid exposure, obtain special instructions before use. The product must be handled in accordance with good industrial hygiene and safety procedures. Only experienced and properly instructed persons should handle gases under pressure. Consider pressure relief device(s) in gas installations.
